His estate filed 19 February 1885 mentions the widow P J Denÿssen, Petrus Johannes Denÿssen, Laura Ann Denÿssen, Inez Denÿssen, Grace Elizabeth Denÿssen, Ella Dorethea Irene Denÿssen. His Obituary appeared in the Cape Argus 15 December 1883.

Petrus Johannes Denyssen (1811-1883) was born in Cape Town on 18 August 1811. His father, Daniel, originated from Holland and was Fiscal (or Attorney-General) in 1813; and later practising as an advocate.

Petrus graduated in Leiden *cum laude*, and afterwards read in the chambers of Sergeant Wylde (Wilde). He was called by the Inner Temple on 18 November 1836. On 12 July 1837. he was admitted to the Cape Bar; but in 1840 left the bar to become secretary to the Cape Town Municipality for 15 years. From 1856 to 1865, he was once more at the bar and had a good practice. He was then appointed to the Eastern District Court at Grahamstown. On the 1 September 1868, after three years, he moved to the Cape Supreme Court as a judge. In 1877, he retired on pension and went to live in Bonn, Germany where he died on 15 November 1883.

"He was a man of determined character but of very affectionate disposition. He was courteous and dignified, and manifested great common sense and ability as a judge."

"He was the son of Daniel Denyssen and Magdalena Elizabeth Smuts. He went to Holland in 1830 where he took his LLD at the University of Leyden after which he moved to London. He particularly excelled in cases relating to estates. He married twice and his second wife was Clara Esther Law. He had 3 children from the first marriage and one from the second."
