

BENJAMIN FRANÇOIS DUMINY

South Africa Medal 1877-79: bar 1877-78 was awarded to Royal Navy, Army and Colonial Units who took part in operations against the Galekas and Gaikas between 26th September 1877 and 28th June 1878; and against Chief Pokwane between 21st and 28th January 1878, the so-called 9th Cape Frontier ("Kaffir") War of 1877-78.

BACKGROUND INFORMATION

Benjamin François (Francis) Duminy was born 5 February 1839, the eldest of fourteen children born to Francois Jean van Helslandt Duminy and Maria Johanna Emerentia VAN OOSTERZEE. He was a medical practitioner who qualified in Aberdeen, Scotland in 1861, town counsellor in East London and Dordrecht and a farmer of substance in the Dordrecht district of the eastern Cape. He married Elizabeth Sophia LOUW in Durbanville on 24 August 1863. She bore him two sons and three daughters. He died on 26 April 1892.

The University of Aberdeen was created through the merging of King's College (founded in 1495) and Marischal College (founded in 1593) on 15 September 1860 in accordance with the 1858 Universities (Scotland) Act, which also created a new medical school at Marischal.

Cape Frontier Wars (Kaffir or Kafir Wars, 1779-1879) represent a 100 years of intermittent warfare between the Cape European colonists and the Xhosa agricultural and pastoral peoples of the Eastern Cape, in South Africa. These were amongst the most prolonged struggles by any African peoples against European expansion.

In 1877-78 the Ngika and Gcaleka sections of the Xhosa, who had acquired guns on the diamond fields and were eager to regain lost lands, took up arms against the colonists and their allies, the Mfengu.

After these wars, the remaining Xhosa territories were gradually incorporated into the governance of the Cape Colony government and thus under British rule. The Transkei was incorporated into the Cape as a separate territory in 1879. It consisted of Galekaland, which was conquered in 1877-78; and Fingoland and the Idutywa reserve, which were annexed in 1879.

BENJAMIN FRANCIS DUMINY GENEALOGY

For a fascinating recounting of the origins of the Family Duminy in South Africa, readers are referred to "Francois Renier Duminy 1747-1811: French Mariner and South African Pioneer", author Andrew Duminy, publisher Protea Book House, 2005

The purpose of this presentation is solely to place in historical context the former owner of the medal described above. Though the text is detailed, the author makes no claim to it being comprehensive.

François René, aka. François Renier Duminy, was born a foundling in Lorient, Bretagne on 4 October 1747. He is speculated as having been the son out of wedlock of Antoine Lebre Duminy by one Anne le Goff.

It is thought likely that the surname Duminy is a *nom de guerre* after a patron in the French army.

The founder of Duminy family in South Africa, François Renier Duminy first visited the Cape of Good Hope in 1771. Later, he married one Johanna Margaretha Nöthlingh in Dutch Reformed Church, Cape Town on 2 February 1777. She was born 29 June 1757, baptised 7 July 1757 and died 25 February 1807, the daughter of Benjamin Nöthling and Johanna Lombard.

He served as an officer in the French East Indian Company (De Compagnie des Indes) before entering private service and later the Dutch East India Company as a sea captain. He was Equipage Master for the entire DEIC administration (March 1786-July 1787) and *Capetain du Port* for Simonstown (1803-1806). He was a slaver, entrepreneur, cartographer of note, farmer, public commissioner and an eminent, decorated freemason both in Lorient, France and the Cape of Good Hope Lodge.

His later years were marred by ill-health and financial distress as his privileged rank and highly remunerative employment was withdrawn.

Duminy died at 19 Graave Street, Cape Town aged 64 years on 26 May 1811. [KAB CJ 2632.41](#) [MOOC 7/1/53.32](#)

Dr Benjamin Francis Duminy graduated from Aberdeen University Medical School (M.B.Aberd) and Royal College of Surgeons, London (M.R.C.S [Lond]) in 1861. He was licensed to practice in the Cape Colony on 1 April 1862 whilst then resident in Durban, Natal. He became a medical practitioner at East London. He became a Town Counsellor for a brief period in February 1877 when he was elected for Ward 1 at the start of the second Triennial Council. He resigned in April 1877 and did not seek re-election. Duminy left East London in the mid-1880s and settled at Dordrecht where he became a member of the Wodehouse Divisional Council. He died at Dordrecht on 26 April 1892 at the age of 52, after a long illness.

On 3rd January 1884, he raised a £3000 bond, registered on 5th February 1884, for the purchase of "Willow Park" (formerly "Ou Kraal" or "Ox Kraal") in the division of Wodehouse (later Queenstown), in the fieldcornetcy of Groote Vlei.

On his death, Duminy left a considerable estate. The following are of interest:

1. legacies were only to be awarded on his children attaining the age of 25 years
2. separate provision was made for the education of his minor children, the youngest daughter and two sons, any surplus funds accruing later to the estate
3. Francois Reynier had a pre-emptive right to purchase "Willow Park" from the estate, which right he appears not to have exercised
4. at one stage "Willow Park" was rumoured to have had gold deposits on it; this was later dismissed as nonsense by the executor
5. circa 1902, the executors of the estate of a certain Barnard (sic Bernard) of Klerksdorp drew the attention of Duminy's long-suffering executor ("the only live remaining ...") to the fact that Duminy owned farms in the South African Republic (later Transvaal). These were "Diepwater" district Rustenberg; "Honigfontein" and "Rietfontein" district Potchefstroom; "Kafferfontein" district Waterberg. Based on a power-of-attorney granted Barnard by Duminy in June 1890, they claimed the right to sell the farms "for realization of certain conditions disclosed in said Deed" (registered and dated May 1891). Duminy's legal heirs disputed this right. A legal opinion was sought of the Hon.W.P.Schreiner KC. in October/November 1902. He opined that the matter needed to be argued in the Transvaal.
6. Again his opinion was sought in July 1903 regarding execution of the will in relation to dividing the monies following the completion of the children's education.
7. On 23 March 1914, the 6th and Final Liquidation Account was presented to the Master of the Supreme Court by an exasperated executor with the following note: "The Estate still stands possessed of a farm in the Transvaal known as Kafferfontein No.176 district Waterberg which constitutes an asset of the Transvaal Estate and it is impossible to realize (its value) in so far as the assets within the Cape Province are concerned these have all be(en) realized (.) the Estate can therefore be considered as having been fully liquidated".

Duminy R2434/80: This record consists of minutes from the Colonial Secretary, Transvaal, to various government officials. However, there is the following note in the file: "Stukke wat in hierdie band ontbreek: R2413, 2418, 2420, 2434, 2436, 2446, 2447. Die vermiste stukke word in die register vermeld."

The Death Notice of François Jean van Heislandt Duminy (and others) highlights the many spellings of the original VAN HELSLANDT.

The file contains a detailed Holographic Will of six pages full of imperatives and somewhat critical in tone. It is interpreted by the Master's office as effectively disinheriting some offspring on the basis of debts outstanding on loans.
