In a certain **John Scotton**'s will (extracted from the Registry of the Archdeaconry Court of Leicester: "In the Name of God Amen I John Scotton ....") dated 8 December 1770, writes of his brother THOMAS, and THOMAS' sons, THOMAS and JOHN and daughter ANN in that order. The will was "Proved on 29<sup>th</sup> August 1776 before Rev. John Jervis Clerk Snr. upon the oath of Thomas Scotton, the sole executor to whom was granted E....."

In 1861, the household consisted of John SCOTTON, Son, aged 50yrs (b. 1801) and his wife, Mary SCOTTON aged 40yrs (bc. 1811), their children, Matilda SCOTTON aged 12yrs (bc. 1839), Priscilla aged 9yrs (bc. 1842), Thomas aged 7yrs (bc. 1844), William aged 4yrs (bc. 1847) plus 2 servants Elizabeth ASTILL and Charles WILLIAMS. Dead are Mary Ann (b July 1836 d. 5 September 1836), John (b. 1840 d. 1 January 1845), Ann (b. March 1845 d. 118 August 1848)

The baronetcy appears to be DE VERDON, details of which are scanty (2005).

Family lore has it that offspring of Matilda became the Dame of Sark.  
Extensive research on my part has failed to support this claim; and the Collings family, I think correctly, repudiates any link.

The House of Collings has ruled Sark since 1852:

1853 - 1882 Rev William Thomas, son  
1882 - 1927 William Frederick, son  
1927 - 1974 Sybil Mary, daughter, better known as Sybil Hathaway, after her second husband's name, and the Dame of Sark.

Her estate was left to Alice Bailey (née Hubbard) (niece), Charles Andrew Hubbard (nephew), Emily Elizabeth Hubbard (niece), Edith Mary Hubbard (niece), Annie Blodwin [sic] Atkin (cousin), Robert George Aubrey Atkin (God child). The will was lodged by Robert Tevidale [sic] Atkin (Executor) and Ernest Edward Ascott-Evans (Executor).

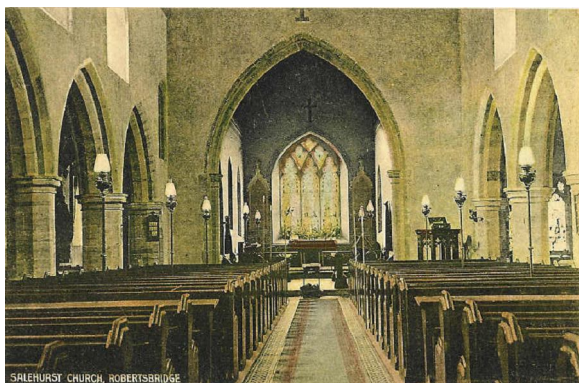

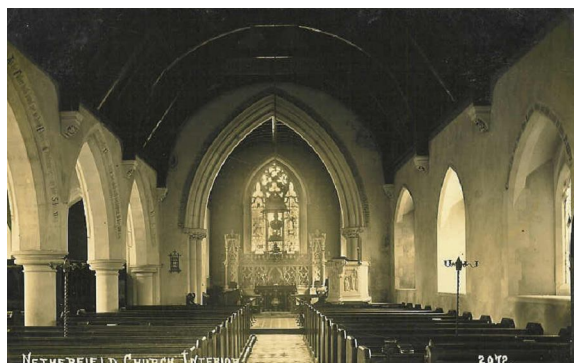

Hannah Ellen Williams was the sister of Annie Williams; and a botany mistress at Netherfield, Battle, Sussex, who gave up her job on the death of her sister so as to look after the offspring. It is speculated that she took up residence in Claybrook on 29<sup>th</sup> August 1889.

On the death of William Scotton (Snr) it is said that the estate was left to his sons who "went farming" in South Africa, lost their inheritance and left their step-mother destitute. She returned to teaching, her daughters "went into service" except for Olive who was given a sound education.

British Army official records say Donald Victor Scotton, Private 63679, 2<sup>nd</sup> (15<sup>th</sup> Batt.) Battalion, Auckland Regiment, New Zealand Expeditionary Forces died Saturday 24 August 1918 aged 25 years at Greyvillers near Baupaume. He is buried in the Adanac Military Cemetery, Miraumont, Somme, France (Ref:II.I.16). There is a memorial in the family church of St.John the Baptist, Netherfield dated 2 November 1919

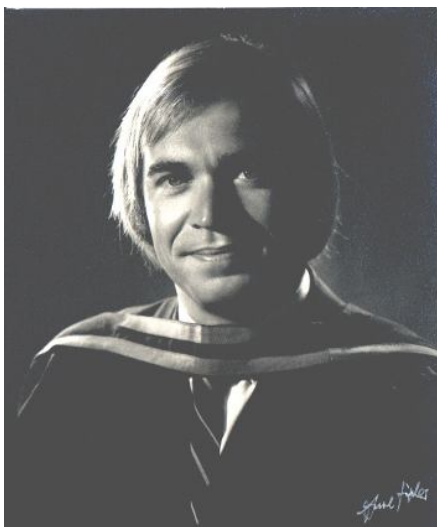

## The SCOTTONS of Bitteswell, Claybrook and Lutterworth in context

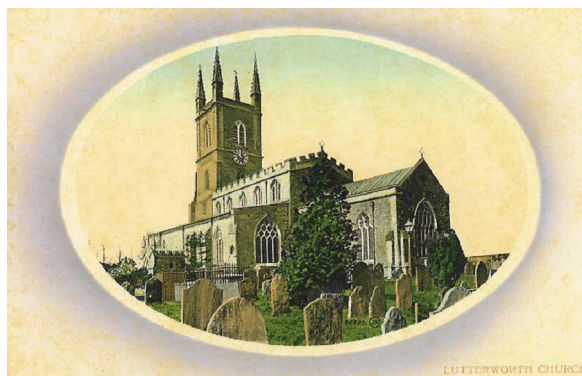
