## MESSRS ARNDT & COHN

The CORRESPONDENCE SERIES is an investigation into the background of recipients of British prestamped postal stationery. The "collection" was purchased in South Africa in 1999 as a job lot, the which took me six months to sort and mount, creating a collection spanning 140 years. I have no idea of the provenance.

The Reference work is British Postal Stationery, A K Huggins.1970. The first date with catalogue number refers to the year when the pre-stamped envelope was first issued; the second, the year when the envelope was actually used.

## **Comment:**

Carl Johann Cohn (born Neustrelitz 19 November 1857, died Hamburg 7 May 1931) was an Hamburger, businessman, politician of the German Democratic Party (DDP) and Senator. In 1883, together with his brother, he established the firm of Cohn & Cohn Arndt, operating in southern Africa as Arndt & Cohn, having branches in Cape Town, Durban, Johannesburg and Port Elizabeth. Cohn & Cohn Arndt went on to become among the largest and most prestigious Hamburg import and export companies.

Late 1900, Arndt and Cohn received a consignment of gold from Wilcken & Ackermann of Lourenço Marques and in the process became embroiled in the saga that was to become known as The Kruger Millions, a story which in the minds of many has never been satisfactorily resolved.

In 1938, Cohn & Cohn Arndt of Alter Wall 32 was aryanised by the Nazis.

On 5<sup>th</sup> March, 1956 ARNDT AND COHN Limited of Adelaide House, London Bridge, London, E.C.4 was placed into voluntary liquidation.
