DR CHARLES WILLIAM HUNTER

a biographical sketch

Charles William Hunter was born in Forfar, Angus, Scotland 3 July 1861 i ii.

He qualified in Edinburgh in 1886, and registered on the 28 July 1887. For 9 years he was a respected member of his father's practice in Forfar. He came to southern Africa in 1895 after the doctors in Scotland had given him 6 months to live on account of an unspecified lung ailment, presumably either severe asthma or, more likely, tuberculosis. He practised in Kimberley, Douglas iii and Campbell with the dry climate apparently affecting a complete cure.

He returned to Scotland in 1896, spending 3 years there gaining a Masters in Surgery, with special expertise in ophthalmic surgery and anaesthesiology. In 1909, he was awarded an M.D. by the University of Edinburgh.

On his return to South Africa in 1899, he was requested to forego Kimberley and go to Koffiefontein. There he functioned as medical officer to the Koffyfontein Mines Ltd., and surgeon to the then Republican Koffyfontein Town Hospital ^{iv} until, in May 1901, his contract with the latter came to an end "the funds being exhausted". With the occupation of Koffiefontein by the British forces ^v, he was appointed Civil Surgeon in charge of the 3rd Battalion Kings Own Scottish Borderers detachment. He managed two hospitals in the dorp, having turned the Town Hall into a second hospital solely for the care of Republicans. He became bilingual in English and Afrikaans, and applied himself in public service without fear or favour. The testimonial from the Officer Commanding the 3rd Battalion, Capt. Harold Crichton-Browne ^{vi}, bears testimony to his diligence, humanity and skill. After the war, he was warmly congratulated by the authorities for his services to both friend and foe alike, and was awarded both the Queen's South Africa Medal (Q.S.A) and eventually the King's South Africa Medal (K.S.A) in recognition thereof.

He acted as District Surgeon to Koffyfontein from October 1899 – April 1900, September 1900 – May 1901 and June – December 1901 vii, where after he received a full-time appointment at the princely salary of £50.00 per annum viii. This had followed considerable, inexplicit opposition on the part of the then Acting Resident Magistrate and commander of the Koffyfontein Defence Force, Capt. (later Major) J W Robertson. He mooted numerous people as suitable candidates rather than Hunter, and all this in the face of admirable references which already were lodged with the Army Administration and known to local medical illuminate ix.

Hunter, in turn, appears to have been well connected for, over a period of months, he cited Dr Ashe of Kimberley ^x, Jas(per) Hill Esq., Member of the Legislative Assembly, The Very Rev. Archdeacon Holbeck, Colonel Duke R.A.M.C ^{xi} and Colonel Allin ^{xii} as persons who could be approached for local references. However, the proposition made obliquely by H F Wilson ^{xiii} Secretary of the Orange River Colony Administration to Robertson that Dr Yule ^{xiv} be asked to adjudicate the matter, together with correspondence from the Manager of Koffyfontein Mine, Walter S Whitworth ^{xv} finally appears to have focussed minds and ended the unpleasant debate.

From correspondence with Captain Trollope xvi, Chief Superintendent, Refugee Camps, Bloemfontein, we learn that Hunter had travelled to Rhodesia to pursue a mining proposition, and preparatory to this had resigned his commission. This alleged resignation is contrary to the official record which shows him as resigning from Army service in 1905.

Aside from running a private practice, for many years, Hunter was District Surgeon, Medical Officer to the Imperial Railways and Medical Officer to the Koffiefontein Mines, which position he retained the appointment till the mines ceased operations. He served the community for a considerable period as Justice of the Peace (1902 onwards xvii), Councillor and for a time as Mayor.

He married Margaret Nicoll [b. 1 December 1864 Inverarity and Methy, Angus, Scotland do. James Nicoll and Mary Copeland] in Forfar on 9 April 1889. Together they had four children ^{xviii}. She died in Kimberley on 10 July 1941 ^{xix}; and he at Koffiefontein on 17 July 1945 ^{xx}.

Excerpt from Minute of Special Meeting of the Directors of the Forfar Infirmary held within the Board Room of the Institution on 31st

August, 1895, Ex-Provost Doig, President, in the chair.

(Inter alia)

II. - Resignation of Dr. Hunter.—The Secretary produced and read a letter of date 22nd inst., from Dr. Charles W. Hunter resigning his position and appointment as one of the Medical Attendants of the Forfar Infirmary owing to his being advised to go abroad for the sake of his health. The Directors while reluctantly accepting his resignation desire to record their high appreciation of Dr. Hunter's valuable services to this Institution during the past eight years in which he has been on the Medical Staff, their deep sympathy and regret at the cause of his resignation, their most earnest hope that his contemplated change will as is fully anticipated completely restore him to robust health, and their most confident commendation of him both as a highly capable medical man and as a gentleman deservedly held in the highest esteem in this community. The Directors further instructed the Secretary to send Dr. Hunter an extract of this Minute duly attested with the view of his using it if, and as he may think fit, where he may settle.

dated 18th February 1902 from by Walter S Whitworth, Manager of Koffyfontein Mine addressed to H F Wilson, Secretary to the O.R.C. Administration

Sir

I beg to acknowledge receipt of your letter No. 188/02 Public Healthy Dept (Confidential) dated Jan., 31st but only received here this morning.

With reference to Dr C W Hunter, it is quite true that Dr Hunter has been promised the appointment of Mine Medical Officer, when we are able to recommence work, and with regard to your query, as to whether in my opinion it is advisable that he should be confirmed in the appointment of District Surgeon at Koffyfontein, I should be inclined to say yes-

Here is Koffyfontein – and especially we the Mining Company – have had a good deal of trouble in the past with regard to a good Medical Officer, - so many Medical Men out in the country being utterly & entirely unreliable & unfitted for their professional duties owing to their drinking, while others again are too lazy to be worth their salt.

Now with a family of from 500 to 1,000 Kaffirs to keep in good health – (because it does not pay to have to feed a Compound full of sick boys and get no work from them) having a good Medical Man is a very important point and when DR Hunter spoke to me with reference to this appointment at the Mine, just before he went to Bloemfontein. I told him he should have it on our recommencing work but he must understand that his keeping it would depend upon his keeping our Kaffirs in as good health as possible – while in the future if we got a railway communication and increased our native employees to probably 2,500 to 3,000 – it would then probably be necessary to have a Medical Officer to attend top our Compound only & be restricted from other practices.

Now, it was through my endeavours as a Member of the Koffyfointein Hospital Board that Dr Hunter originally came to this place – and at first, I musty say, I was not very favorably impressed with Dr Hunter, he certainly did not gain my confidence as a medical man, although I could not have mentioned quite why! – but as regards being absolutely steady, reliable & not lazy I have never had any complaint whatever to make against Dr Hunter – whilst as he treated our native employees through the early part of the war very successfully & has been very successful I consider with many surgical cases during the war and in practice generally – I am inclined to consider my little earlier prejudice against Dr Hunter as not correct nor fair

It was therefore, looking at the matter from this point of view, only wise to try and make sure of Dr Hunter's services – as I know of no one who will suit us better, but a good many who would suit us worse – Dr Hunter had some private feud with our late Commander Major Robertson – but although I am a much greater friend of Major Robertson than I am of Dr Hunter, I can, on a point of this kind, only look upon it as an unfortunate occurrence, but not one to make any difference as to Dr Hunter's appointment being advisable or otherwise.

I should therefore personally be glad to hear that Dr Hunter's appointment as District Surgeon of Koffyfontein has been confirmed.
